Messages from our Leadership



Dear Friends,

This Impact Report reflects the growth of Episcopal Community Services of the Diocese of New Jersey (ECS-NJ) into a more mature organization supporting Gospel Justice throughout the diocese. The Board of Directors held its first two meetings and organized the new 501c3 corporation.

We give thanks for our first Executive Director, Deacon Trisha Thorme, who provided inspiration and spirituality as well as the leadership and organization skills needed to promote our growth prior to her move to Rhode Island. We are profoundly grateful to Father Dave Snyder, who stepped up to serve as Interim Executive Director and to Melanie McLaurin, who did an outstanding job in her first full year as Assistant Director of Communications and Development, and to all the members of the Advisory Council without whom none of this progress would be possible.

In 2024, we passed the significant development milestone of over one million dollars raised since our beginning in December of 2020. We funded 8 grants totaling \$95,066 to support community-identified projects. We provided liturgical support for ECS Sunday that was also Rogation Sunday on May 5. We held workshops on Data that makes a difference: using neighborhood data to inform justice work and Asset mapping. The fall summit was on Code Blue Housing, providing shelter during cold nights. We advocated for the Poor People's Campaign and their voter registration efforts.

In 2025, we expect to hire a new Executive Director early in the year. We plan to expand the number of churches and people working for Gospel Justice through prayer, education, advocacy, grant support and fund raising.

But we have only just begun and I am convinced that God has plans for this organization which we can't even begin to imagine. The challenges we face are formidable, but together we will continue to make a lasting and sustainable impact on the ministries of the congregations of the Diocese of NJ and on the lives of the people they are privileged to serve. In closing, I want you to know that am humbled by the remarkable impact ECS-NJ has made in just over four years. I will be forever grateful for the honor and privilege of having had a small role to play in the launching of this organization, first as Development Officer and, for the past eight months as, Interim Executive Director. May God continue to bless the important Gospel Justice work we are privileged to do together.

Through initiatives like voter engagement campaigns and community programs, we strive to address systemic inequalities, promote civic participation, and uplift those most affected by poverty and injustice. Together, we can build a future where everyone has the tools and support to thrive.

ECS's 2024 Workshop Series: Equipping Communities with Essential Knowledge

In 2024, ECS offered three dynamic Zoom workshops, delivering valuable insights on critical topics to support community initiatives.

Spring Workshops: Leveraging Data for Grant Writing

ECS began the year with workshops focused on gathering and using data to strengthen grant proposals. The Rev. Dr. Molly James led an engaging session on gathering and analyzing quantitative data from existing sources, empowering attendees with tools to interpret and present impactful statistics. Dr. Jennifer Dunkle, a respected academic from the Department of Social Work at Stockton University and now a member of Rutgers, New Brunswick's Institutional Review Board, introduced participants to asset mapping. This qualitative approach to data collection highlighted strategies for identifying and utilizing community resources effectively.

Preparing for Code Blue: A Fall Workshop with actionable steps to launch effective emergency services.

ECS's workshops throughout the year empowered communities with practical knowledge, fostering collaboration and enhancing their ability to make a meaningful impact.

EDUCATION & ADVOCACY

As colder weather approached, ECS collaborated with Trinity, Asbury Park, to deliver an informative session on setting up a Code Blue program within parishes. The presentation opened with a historical overview of homelessness and income inequality, providing essential context for the challenges faced by vulnerable populations. Practical guidance on logistics and funding followed, equipping attendees

> ECS-NJ partnered with the New Jersey Poor People's Campaign (NJPPC) to engage underrepresented voters, particularly poor and low-wage workers, ahead of the November election. Volunteers were invited to assist during their free time to help ensure local residents were registered, informed, and encouraged to vote.

CREATING **OPPORTUNITIES**

With the support of a grant from Episcopal Community Services (ECS), Christ Church partnered with Emanuel Lutheran Church and Unity Square Community Center, a ministry of Catholic Charities, Diocese of Metuchen, to create the Choice Food and Resource Center (CFRC). This collaboration enables the churches to better serve the New Brunswick community by combining resources and offering guests a more accessible and efficient experience. Located in one of the city's poorest areas, Unity Square provides a fully handicap-accessible facility with first-floor space, accessible bathrooms, an indoor waiting area, and a large overhead door for deliveries.

The CFRC allows families to schedule monthly appointments to select food tailored to their needs, offering a greater variety of items sourced through Replenish, the Middlesex County food bank. The Unity Square van ensures reliable transportation of these supplies. Christ Church's personal care ministry continues to provide essential items, such as diapers and sanitary products, which parishioners package monthly. Volunteers also assist with guest registration, food distribution, and unloading deliveries, helping to meet the needs of the growing number of households served.

The ECS grant enabled CFRC to modernize its operations, transitioning from paper to digital record-keeping with the purchase of electronic tablets. Additionally, the grant funded staff support during the transition, including a Food Coordinator and bilingual Community Organizers to better serve the largely Spanish-speaking community. Since the move to Unity Square, CFRC has expanded its reach, serving 358 households in November 2024 compared to 167 in December 2021.

CFRC also connects guests to vital resources through partnerships with local organizations offering health screenings, family wellness services, shelter assistance, and help with SNAP benefits. The collaborative efforts of Christ Church and its partners reflect a shared commitment to addressing community needs and fostering connections that make a lasting impact.

Food pantry (Christ Church) in New Brunswick

FCS-N grants are designed to expand existing compassion and justice ministries of congregations and make new ones possible. Since the Fall of 2021, we have awarded almost \$479,000 to 37 churches in the Episcopal Diocese of New Jersey. Projects proposed for ECS-NJ funding should address at least two of the following objectives:

- color
- To engage, collaborate and partner with other organizations, including faith-based, secular, community, governmental, etc.
- efforts, particularly those affecting underserved or marginalized communities.

Because of the generosity of donors, we have been able to support the launch or expansion of many ministries across the Diocese, supporting churches providing food, shelter, education, legal assistance, medical equipment, employment assistance & training, community support and so much more.
